## **Program Overview**

Eisenhower Residential Treatment Facility (RTF) provides Residential (ASAM Level 3.5) healthcare services to treat substance abuse and co-occurring psychological disorders (Dual Diagnosis). The primary objective of the program is to provide comprehensive, evidence-based treatment to restore functioning and return Service Members to unrestricted duty status.

We provide a safe and structured environment to assist Service Members with recovery addressing health and psychological factors related to substance misuse.

While in treatment, the care team will work together to develop a treatment plan that is holistic and individualized. The treatment plan incorporates integrated therapies and services to address all aspects of addiction.



#### **Referral Process**

Referrals are accepted from Licensed Independent Providers within Air Force Alcohol and Drug Abuse Prevention and Treatment (ADAPT), Army Substance Use Disorder Clinical Care (SUDCC), Navy Drug and Alcohol Program Advisors (DAPA), and Marine Corps Substance Abuse Counseling Centers (SACC).

Service Members must be enrolled in the service equivalent SUD program and meet criteria for DSM-5-TR diagnosis of Substance Use Disorder, Moderate or Severe. Providers are required to submit a referral packet for RTF Screening and have written authorization from their unit Commander.
